- 4 On basis of the notification No.- 434-EDN(CS)/10M-95/14 dated. 16/07/2020 of the Dept. of Higher Education, Govt. of WB it is here by informed to all concerned that the provisionally admitted Students must report to the Admission Section of the university for confirmation of their provisional admission through verification of documents failing which his/her provisional admission will be treated as canceled.
